# City Park Ambassadors to Engage with Public on Physical Distancing

To Stop the Spread of COVID-19

## **Summary**

On April 8, 2020 the Province of BC announced the closure of provincial parks, in response to the COVID-19 pandemic. This closure affects provincial parks only - at this time, most parks and trails within the City of Nanaimo remain open. The exception to this is playgrounds, sport courts (hockey, lacrosse, pickle ball, volleyball, basketball, tennis), skateboard parks, Steve Smith Bike park and four gated dog parks (Beban, Wardopper, St. George Ravine and Northfield) which remain closed.

To stop the spread of COVID-19, the City of Nanaimo Department of Parks, Recreation and Culture has created a new area of the Parks Ambassador Program by sending out trained Park Ambassadors to two of Nanaimo's busiest parks. This program is intended to create awareness of the importance of practising physical distancing while in the parks or on the trails, as well as share other heath-related actions that individuals can take to stay healthy and safe during the COVID-19 pandemic.

Starting this Easter long weekend, Phase 1 of this program will see ambassadors at areas along the waterfront in Maffeo Sutton Park (Queen Elizabeth II Promenade, Sway-A-Lana Lagoon, Georgia Park, McGregor Park, Diana Krall Plaza and along areas of the Port Authority's Harbourfront Walkway) and Westwood Lake Park to remind residents to always practice physical distancing while in Nanaimo's parks and while on the trails.

Physical distancing is defined as being at least two metres (6 feet) away from anybody who is not part of your household. If this pilot program is found to be successful, the City will consider expanding it other busy parks and trails.

These ambassadors will easily be identified by the public. They will be wearing bright yellow Parks, Recreation and Culture vests.

Strategic Link: The City of Nanaimo is committed to the safety and well-being of its residents.

# **Key Points**

- Social/physical distancing has been shown to be effective in preventing the community spread of COVID-19, which is why City Parks Ambassadors will be at Westwood Lake Park and Maffeo Sutton Park starting Easter long weekend to encourage physical distancing.
- City Parks Ambassadors are not authorized to detain an individual as a result of a contravention or suspected
  contravention to a Public Heath Order. They are also are not authorized to issue a fine or penalty associated
  with a breach of the public health orders.
- If this pilot program is successful, City of Nanaimo staff will expand it to other busy parks and trails.
